SI. No. The school is directed to ensure that :

The total number of sections of Bal Vatika shall be restricted to 3 (1 section each for Bal Vatika I, II & III). The total number of sections from classes I to XII shall be restricted to 15. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed including Bal Vtika. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Bye laws and availability of rooms of >500 sq ft PRINCIPAL

The grab bars inCWSN toilets are inappropriately placed, these are not placed Shahjahanpur (U.P.) both sides of WC. One grab bar is seen fixed on the wall which will be difficult to hold

by a disabled person. The CwSN toilets are not seen on every floor. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.

- Seating facility in computer lab is inappropriate (stools are there). Hence the school is 3 directed to upgrade the computer lab as per Board's SoP and submit the compliance within 3 months.
- One sink with water supply is seen in Physics lab which is not required as per 4 guidelines. Hence the school is directed to upgrade the lab as per Board's SoP and submit the compliance within 3 months.
- Library is seen understocked and seating facility in library is inappropriate (stools are 5 there). Hence the school is directed to upgrade the library as per Board's SoP and submit the compliance within 3 months.
- Building safety certificate dated 20-11-20 uploaded by the school does not have 6 number of floors of the building and there is no validity period mentioned. The school is directed to obtain fresh building safety certificate mentioning all details correctly and upload the same on SARAS portal within 3 months. (suggestive format is available with circular No.12/2022).
- The school shall conduct training of its teachers with CoE Noida within 3 months and 7 submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these recording transfers, shall be borne by the school.
